DISCOUNTS ON TUITION FEES FOR FAMILIES WITH CHILDREN AT XENION HIGH SCHOOL AND XENION JUNIOR SCHOOL

- For families **with 2 or more children** at the school, **10%** off the fees amount for **each child** for the whole duration of their studies.
- A further discount of 5% will be offered on tuition fees only, except the registration which is the first instalment, when these are paid in advance for the entire year, on the date of registration.
- All discounts will remain in force even after the graduation of older children in the family.

ALUMNI HONORARY CONCESSION

5% on tuition fees for all 6 years of study to the children of the family when at least one parent has studied and graduated from Xenion High School.

ADMISSION FEE

- **Entrance/Placement Exams** for new students - **€100**
- **Preschool - €150.00** (compulsory one-off payment only for new students entering Preschool)
- **Junior School Students - €200.00** (compulsory for new students entering the Junior School)
- **Annual Registration Fee** (Compulsory for continuing pupils at Junior School) - **€60**

MISCELLANEOUS CHARGES

- **School Uniform, Books & Stationery:** Payable in August.
- **Formal school outings & other special projects:** Students are charged separately before trips and other educational visits take place.
- **External Exams:** Any external exam fees are NOT included in the tuition fees.

PARENTS' ASSOCIATION SUBSCRIPTION

All families are registered as members of the Parents' Association with an annual fee of **€50 per child**. This amount includes cover for 24hr personal accident insurance for each child as well as presents given, and events organised by the Parents' Association. The Parents' Association is payable upon registration

REVISED TUITION FEES

The school has the right to revise tuition fees, without prior notice.

Any possible increment on fees has a cap of 5% per year.

REFUNDS

Fees, Books and Uniform purchases paid to the school are non-refundable and non-exchangeable.

NOTES:

1. Fees for **Preschool include breakfast, lunch, field trip excursions in the area and after school clubs.**
2. Fees for **Junior School include field trip excursions in the area and after school clubs.**
3. Registration for the next school year is subject to full settlement of all outstanding tuition and/or other fees.
4. The school has the right to withdraw scholarships, monetary prizes, or discounts in case of overdue fees or serious disciplinary incident.
5. Additional fees may be applied for any supplementary courses.
6. Progress reports and/or other certificates will not be issued if fees or other charges are overdue.
7. For students who are entitled to any grants or subsidies by the Cyprus Government or any other organisation or authority, it is the obligation of the parents/guardians to settle the school fees in full irrespective of when the subsidy is received.
8. Please note that students cannot be insured after the 1st of September if the Parents Association fee is not paid upon registration.
9. In the event of a student, for any reason, leaving the school before the end of the academic year, their tuition fees must be settled in full.
10. The inability to continue with school lessons, for whatever reason, does not exempt the parent/guardian/student from the obligation to pay the school fees for the whole academic year. Any balance of fees due upon the departure of a student from the school, irrespective of the date of departure, must be paid in full.
In the event that fees of a student were paid in full, and the student ceases to attend the school, no refund is applicable.
11. Books and Uniform purchases paid to the school are non-refundable.
